**DIVISION III NOMINATING COMMITTEE**

**OPERATING POLICIES AND PROCEDURES**

***Legislated Duties and Responsibilities:***

1. **Bylaw 21.9.5.9.2** - Coordinate nominations for the Division III Management Council, all standing committees that report to the Management Council, all Division III sports committees and all Division III positions on Association-wide and common committees, pursuant to applicable legislative requirements.
2. **Bylaw 21.9.1.3** - Ensure that a Division III conference or institutional representative on a Division III Committee whose term has expired may not be replaced by another representative of that conference or institution for a period of at least one year.  
*Exception:* Division III Women's Rowing Committee, Division III Women's Ice Hockey Committee, Men's and Women's Skiing Committee.
3. **Bylaw 21.9.1.3.1** - If an interim vacancy occurs and the committee member has equal to or more than one-half of a term remaining, then that committee member may be replaced on that committee by another representative of the same conference or institution only for the remainder of the term.
4. **Bylaw 21.9.1.2** – One Member per Playing Conference. The membership of a Division III “playing conference” may not be represented on any committee by more than one individual.  
*Exception:* Management Council and Student-Athlete Advisory Committee representatives.

***Guiding Principles and Policies:***

1. Committee recommendations should not be discussed outside of the Nominating Committee until the recommendations have been approved by the NCAA Management Council.
2. In the selection of candidates, the following criteria should be considered in no particular order:
  - Balanced representation from conference and independent institutions.
  - Balanced institutional within conferences.
  - Gender diversity.
  - Ethnic diversity.
  - Balanced geographic representation.

In addition to the above factors, when feasible selections may also be based on representation of institutions of diverse size, and of public and private institutions. Nominees should represent institutions in compliance with NCAA Division III membership requirements.

3. Management Council nominees who have significant prior committee experience will be given preference, with the exception of CEOs.
4. Prior committee experience is preferred when appointing for the Strategic Planning and Finance, Financial Aid, Membership, Nominating and Championship Committees.
5. The Nominating Committee expects that committee members serve on one committee at a time. The Nominating Committee can recommend appointment to an additional committee if

circumstances so warrant, however, the Nominating Committee prefers completion of a committee term prior to service on another committee. This policy does not pertain to the selection of Management Council appointees who will be considered regardless of their current committee service.

6. Nominating Committee members should not be considered for appointment to any Association-wide or Division III committees while serving as members of the Nominating Committee. Once their service has been completed, Nominating Committee members should submit their individual nominations in the same manner and by the same deadlines as the membership. *Exception:* In the last year of the CEO's service on the Nominating Committee, the CEO member may be considered for vacancies on other committees with service to begin once their term has expired.
7. In filling coaching positions on sports committees, first preference will be given to individuals who have coaching experience in the same sport and gender as the sports committee. If it is not possible to fill the coaching vacancy with an individual who has coaching experience in the same sport and gender as the sports committee, the Nominating Committee may resolicit nominations.
8. If a committee endorses reappointment of eligible individuals (those who serve less than half of one term), those reappointments are automatically approved by the Nominating Committee.
9. The Nominating Committee generally does not favor term-extension requests for those individuals who have served full terms and are not eligible for reappointment. Doing so limits opportunity for a vital dynamic on committees; namely, that member turnover provides new ideas and perspectives. However, requests for term extensions are permitted and shall be evaluated on a case-by-case basis. Such requests should come through the Nominating Committee's NCAA staff liaison and will be considered during the next scheduled in-person meeting, conference call or electronic action
10. The Nominating Committee will only consider information requested on the Nominee Information Form. Additional materials are not requested and if such materials are submitted they are not to be shared with the Nominating Committee.
11. Nominating Committee members may seek feedback (as necessary) for any committee nominees. The Nominating Committee will seek feedback (by regional assignments) on each Management Council nominee prior to consideration of Management Council vacancies.
12. The Nominating Committee will not consider any in-person appeals by or on behalf of a candidate.
13. When considering a nominee from the same institution as a committee member, the committee member can speak regarding the nominee; however, they should abstain from any vote. In the case of a committee member employed at a conference, the same applies in that they can speak to the person's candidacy; however, they should abstain from the vote.
14. The Nominating Committee may solicit additional nominees for committee vacancies if it so desires.

15. An individual shall not serve on an NCAA sports committee unless the individual's institution sponsors that sport on an intercollegiate basis.
16. When filling the administrator and coaching positions on sports committees, the Nominating Committee should avoid consecutive terms of the same position (e.g. administrator, coach) for a sports district or region.
17. An administrator/coach may be considered as either a coach or administrator to meet the legislated requirements.
18. In an effort to avoid duplicate conference representation, the Nominating Committee will review the composition of the Presidents Council and Management Council nominees from the same conferences. Appointments will then be made taking into consideration the diversity of the Association, including conference, regional, positional, gender and ethnic diversity. [NOTE: This guideline was put into place in an effort to diversify the leadership bodies within the Division III structure.]
19. It is the preference of the Nominating Committee that members refrain from submitting nominations for committee vacancies on behalf of other individuals during their tenure on the Nominating Committee.
20. For sports committee appointments, preference will be given to head coaches over assistant coaches. Assistant coaches should be encouraged to obtain a recommendation from the head coach or director of athletics prior to submission of nomination materials.
21. Assistant coaches will not be considered for vacancies on general committees.
22. If a member of a Division III general committee or sports committee or a Division III member of an Association-wide committee is called up to active military service, the Nominating Committee will solicit nominees from that member's conference. The Nominating Committee will select one of those nominees to fill the position on a temporary basis until the term expires or the member returns from active service, whichever comes first.
23. Regional Advisory Committee experience or similar ranking experience is preferred when making sport committee appointments.
24. The Nominating Committee will meet in-person, via conference call or electronic action only when a majority of the committee can participate. A majority vote of those members participating is required to pass an action.
25. The primary method in determining conference and independent representation will be the ratio of the number of people from the conference or independent group compared to the number of institutional members in a given conference or independent grouping. Conference commissioners will count in the ratio as a person representing the conference. A secondary factor for informational purposes will be the ratio of the number of conference or independent institutions represented compared to the number of members in a given conference or independent grouping.

### **COMMITTEE CHAIR AND VICE CHAIR SELECTIONS**

*Principles:*

- Vice chair assumes chair position at the end of the current chair's service.
- The chair and the vice chair cannot have terms that expire in the same year.
- Committee chair may serve up to two years (legislated).

*Vice chair selection process:*

- Solicit interest/nominations for vice chair position via e-mail.
- Prepare slate of nominees, if needed.
- Vote for vice chair via balloting process.
- Vice chair becomes chair when current chair's term is complete.

### **CONFLICT OF INTEREST POLICY**

The NCAA is a voluntary Association comprised of colleges, universities, conferences and other organizations, and governed through a membership-led committee structure. Within the governance structure, committee members must carefully balance their responsibilities to their respective institutions and/or conferences with the obligation to advance the interests of the Association, the division, or the sport, and ultimately enhance the student-athlete experience. While the fiduciary obligations of committee members to their own institution, their conference, and to the Association ordinarily are not in conflict, it is recognized that as a representative membership organization, committee members' fiduciary obligations are first to their institution, second to their conference, and third to the Association. NCAA committee service involves important ethical and moral obligations. Committee integrity is critical to the decision-making process and includes trust, confidentiality and honesty in all issues and aspects of service and representation. NCAA committee members shall disclose any conflict or potential conflict between their respective personal, professional, institutional, conference, or business interests and the interests of the Association that may affect or otherwise threaten such integrity, in any and all actions taken by them on behalf of the Association, for committee evaluation under this Statement.

In addition to any fiduciary obligation to their institution and conference, committee members also have a fiduciary duty to the Association not to use knowledge or information obtained solely due to service on that committee to the disadvantage of the Association during the term of committee service. Further, a Committee member shall not participate in the committee's discussion or vote on any action that might bring direct or indirect personal financial benefit to the member or any organization (other than the member's institution or conference) in which the member is financially interested. A committee member should also not participate in a discussion or vote for which the member's institution or conference is to be accorded a special benefit beyond benefits shared with other institutions or conferences or is to receive a penalty or disqualification. A violation of either of the above rules by a member of the committee shall not invalidate the action taken by the committee if, following disclosure of the conflict of interest, the committee authorizes, ratifies or approves the action by a vote sufficient for the purpose, without counting the vote of the committee member with the conflict of interest, and the appropriate oversight body approves the action.



A committee member is responsible for advising the chair of any actual or potential conflicts of interest or obligations which he/she may have hereunder, and should recuse him/herself from participating in proceedings, as may be warranted by this policy. Abuse of one's position as a member of a committee may result in dismissal from that position. Where such abuse appears evident, a committee member will be notified by the committee chair and will have the opportunity to present a rebuttal or details of the situation.

### **SPEAKING AGENT POLICY**

The president of the Association and the chair of the Executive Committee are the only individuals authorized to speak on behalf of the Association except as outlined below.

An individual representing a member institution or conference who speaks or opines on an Association issue only has the authority to express the view of that individual or the member institution or conference unless the individual has been designated by the Executive Committee of the Association as a speaking agent of the Association on that issue.

Committee chairs are hereby designated as speaking agents of their committees regarding issues within their committees' jurisdiction on which there is consensus, except that positions of advocacy on behalf of the committee or the Association to be communicated in writing or orally to persons or entities external to the Association must have prior approval by the NCAA Executive Committee or the president of the Association.

The president of the Association is hereby granted authority to designate additional speaking agents of the Association. (*April 2001 Executive Committee minutes*)

### ***Nominating Committee Duties and Responsibilities:***

Key role and expectation for Nominating Committee members is to assist with proactive personal solicitation of nominees to enhance the pool for all committee vacancies and to assist with the appointment process. Major assignments are:

- Assignment of approximately two or three sports based on interest, if possible.
  - Assignment of regional areas of focus for general and Association-wide committees.
  - Continue educational efforts regarding committee service.
1. Process for solicitation of nominees. The committee administration staff:
    - a. Sends direct communication including vacancy, positional, gender, ethnicity and conference requirements to:
      - (1) Division III commissioners.
      - (2) Division III directors of athletics, senior woman administrators and faculty athletics representatives.
      - (3) NCAA Website.
      - (4) NCAA staff.

- b. Forwards all nominee information to Nominating Committee for review and selection.
  - c. Facilitates Nominating Committee meeting.
  - d. Re-advertises vacancies as necessary.
- 2. Nominating Committee member responsibilities (prior to the meeting).
  - Responsible for solicitation of eligible nominees utilizing appropriate resources (e.g., commissioners, ADs).
- 3. Resources available to assist with solicitations.
  - a. NCAA Website.
    - (1) Committee Administration page (vacancies/forms).
    - (2) Division III general, sports and rules/Association-wide committees.
    - (3) Sports/championships (sport websites – sports sponsorship with regional alignment).
  - b. Division III conference representation chart (identifying under-represented conferences.)
