

REPORT OF THE NCAA DIVISION III COMMITTEE ON STUDENT-ATHLETE REINSTATEMENT DECEMBER 2, 2020, VIDEOCONFERENCE

INFORMATIONAL ITEMS.

- 1. **Review philosophy statements.** The NCAA Division III Committee on Student-Athlete Reinstatement reviewed the Division III philosophy statement and the student-athlete reinstatement philosophy statement.
- 2. Review of reports from the Division III Committee on Student-Athlete Reinstatement videoconferences. The committee reviewed and approved the report from its July 1 and October 16, 2020, videoconferences.
- 3. Review of action taken by the NCAA Division III Administrative Committee specific to impact of COVID-19 on waivers processed by student-athlete reinstatement staff. The Committee on Student-Athlete Reinstatement reviewed the chart of actions approved by the Administrative Committee related to regulations and policies impacted by COVID-19 and the corresponding question and answer document relevant to the Committee on Student-Athlete Reinstatement's work.
- 4. **Review of previously approved request list.** The Committee on Student-Athlete Reinstatement reviewed the previously approved request list.
- 5. Consideration of application of COVID-19 Blanket Waivers from Non-Division III and Non-NCAA Institutions/Associations. The Committee on Student-Athlete Reinstatement discussed the application of COVID-19 extension of eligibility waivers from non-Division III and non-NCAA institutions for student-athletes that transfer to Division III institutions and qualified for a COVID-19 extension of eligibility waiver at their previous institution. The Committee on Student-Athlete Reinstatement noted waiver relief provided by non-Division III and non-NCAA institutions/associations would be honored by NCAA Division III institutions.
- 6. Flexible case review. The Committee on Student-Athlete Reinstatement reviewed recent staff decisions that provided relief from established case precedent and/or Committee on Student-Athlete Reinstatement guidelines and archived Request/Self-Report Online Case No. 1085827. All other cases were accepted and will remain available as precedent within RSRO consistent with NCAA Divisions I, II and III Committees on Student-Athlete Reinstatement's Policies and Procedures.

- 7. NCAA Division III Committee on Student-Athlete Reinstatement Guidelines. The committee reviewed and approved revisions to the NCAA Division III Committee on Student-Athlete Reinstatement Guidelines.
- 8. Other business. The Committee on Student-Athlete Reinstatement selected Barbara MacLeod as its next chair.
