

REPORT OF THE NCAA DIVISION III STUDENT-ATHLETE ADVISORY COMMITTEE JULY 20-21, 2024, MEETING

- 1. Administrative items.
 - **a. Roster.** The committee reviewed and updated its current roster.
 - **b. April 14 meeting report.** The committee reviewed and approved the report with no changes.
 - **c. Review policies and procedures.** The committee reviewed its policies and procedures.
 - **d. Expectations of a SAAC member.** The committee reviewed its expectations.
 - **e. Roberts Rules of Order.** The committee reviewed Robert's Rules of Order guidelines document.
 - f. Division III Philosophy Statement and Strategic Positioning Platform. The committee reviewed the Division III Philosophy Statement and Strategic Positioning Platform document.
- **2.** Campus Student-Athlete Advisory Committee (SAAC) contact information. The committee reviewed the Division III campus SAAC liaison contact information and is updating it to help communication between national, conference and campus SAACs.
- 3. Committee assignments. Current SAAC members on committees/working groups gave an informational overview of their tasks and subject matters to get other SAAC members thinking about which committees and working groups they would like to serve on in the future.
- 4. **Division III SAAC subcommittees.** The committee decided that mental and physical health and sports ethics and fan behavior would be the two areas of focus for 2024-25. The committee discussed the importance of participating and the goals set in place the previous year. The group will also be installing a podcast style "hot topics" update for every quarter and continuing the overall commitment to Special Olympics.

- 5. Division III and Association-wide initiatives. The committee was updated on Student-Athlete Day on the Hill. Members of the NCAA Divisions I, II and III SAAC, with the Board of Governors Student-Athlete Engagement Committee members, met with various congressional offices to discuss the role of student-athlete committees and the impacts of current legal and legislative threats on student-athletes, advocating for legislation that would clarify that student-athletes are not employees and ensure a level playing field.
- **6. Emerging Sports for Women.** The committee received an update on the status of women's wrestling as a national collegiate championship sport and other emerging sports.
- 7. Congressional Engagement and Government Relations updates. The committee addressed the critical nature of a House bill regarding student-athlete employment. It discussed the potential ramifications for Division III sports if Congress doesn't act on this issue, highlighting the urgent need for grassroots advocacy from student-athletes. Staff underscored the bill's recent progress through committee and the necessity of obtaining bipartisan support for it to pass in the Senate. Staff encouraged the committee to mobilize its peers to advocate for their interests, noting that a unified voice could significantly influence the legislative process.
- **8. 2025 Legislative Proposals and Updates.** The committee was provided an overview of the Division III legislative process and reviewed the proposals for the 2025 NCAA Convention. The committee will revisit the slate of legislative proposals at its September videoconference before members solicit feedback from their conferences and take official positions at the November meeting.
- 9. Update from NCAA President. NCAA President Charlie Baker highlighted current issues facing the Association, including the House settlement, student-athlete employment challenges and sports wagering. President Baker discussed the importance of finding a framework for compensating student-athletes without disrupting the current model of college sports. He emphasized the need for Congress to address these issues.
- 10. Division III Update. The committee received updates from the governance staff regarding the impact of recent events, such as the House settlement, on the division and Association as a whole. The committee discussed concepts involving mental health resources for student-athletes, sports wagering, various legal cases, NCAA Power Index and championships enhancements. Key proposals included the development of an online module for head coaches and athletic trainers, designed to help them recognize mental health crises and provide adequate support to student-athletes. Additionally, the new post-eligibility insurance policy, effective Aug. 1, was explained. The policy will cover injury-related expenses for student-athletes after they graduate, including mental health counseling related to those injuries.

- 11. Board of Governors update. Isaiah Swann, Division III former student-athlete representative on the Board of Governors, provided insight for the group on his experience as a member of the Board of Governors, and how his work with the congressional engagement heightened the Division III voice as he represents Division III student-athletes. Greg Ricketts, a former football student-athlete at Central College (Iowa), will replace Swann when his term ends August 1.
- **12. Conference and partner conference meetings.** The committee reviewed the list of partner conferences and had no updates. The committee has updated conference and campus advisor contacts to prepare for the new academic year.
- **13. Special Olympics partnership and updates.** SAAC members discussed the division's Special Olympics partnership and reviewed the reporting process for events. The group participated in an event with athletes from Special Olympics Indiana. The final Special Olympics engagement report for the 2023-24 academic year was shared; nearly 4,000 student-athletes dedicated 13,000+ hours to Special Olympics events throughout the year, while raising over \$10,000.
