



**REPORT OF THE
NCAA HIGH SCHOOL REVIEW COMMITTEE
APRIL 11-12, 2024, MEETING**

ACTION ITEMS.

INFORMATIONAL ITEMS.

1. **Review meeting report.** The committee reviewed and approved the report from its March 7 videoconference.
2. **High school review staff updates.** The committee received an update on 2023 work volume, trends, and improvement initiatives from high school review staff.
3. **PSA review and validity review updates.** Staff provided information on how reviews are conducted. The committee did not recommend changes to the policies and procedures or PSA Review trigger list for the 2024-25 cycle.
4. **Review of policies and procedures.** The committee reviewed and discussed updates to its policies and procedures. The updates will be incorporated into the 2024-25 version and approved by electronic vote following the meeting.
 - a. **Internal staff reconsideration.** The committee supported the addition of a policy regarding internal staff reconsideration of an account or course review decision.
 - b. **Criteria for review of instructional models.** The committee supported updates to the criteria for account review to include instructional models in staff's determination of a high school's quality control and integrity of information. The committee supported the removal of criteria for program review now that core-course requirements have been modernized to encompass all delivery models and have eliminated the legislative distinction for nontraditional courses.
 - c. **Extended Evaluation re-evaluation policy.** The committee supported updates to the re-evaluation policies for high school accounts with Extended Evaluation and Not Cleared statuses.
 - d. **Criteria for review of agricultural science courses.** The committee supported updates to the criteria for review of agricultural science courses.
5. **Update on financial literacy courses.** Staff provided an update on internal operating procedures for Economics with Personal Finance course titles.
6. **Discussion regarding academic disciplines.** The committee discussed trends in career and technical education pathways in secondary education. The topic will continue to be researched

and discussed by staff and committee for consideration in changes to the initial-eligibility requirements.
