



**REPORT OF THE
NCAA HIGH SCHOOL REVIEW COMMITTEE
MARCH 7, 2024, VIDEOCONFERENCE**

INFORMATIONAL ITEMS.

1. **Welcome and announcements.** NCAA High School Review Committee vice chair, David Stein, convened the meeting at approximately 11 a.m. Eastern time and welcomed the committee members. NCAA staff liaisons provided information about committee travel for the upcoming annual in-person meeting in April 2024.
2. **High School Review Committee November 16, 2023, videoconference report.** The committee reviewed and approved the report of its November 16, 2023, videoconference.
3. **Update regarding agricultural science courses.** The committee received an update from high school review staff regarding the development of agricultural science course criteria for review, as recommended by the committee during its previous meeting. The committee will review drafted criteria at its next meeting.
4. **Update regarding financial literacy courses.** The committee received an update from high school review staff regarding research and data collection to identify trends in decision outcomes of high school economics courses that incorporate personal finance or financial literacy. The committee will review the data and trends at its next meeting.
5. **Discussion regarding review of high school instructional models.** NCAA staff provided an overview of the current review process for nontraditional core courses and key considerations for updating the criteria for review, given the modernized core-course legislation adopted by Divisions I and II at the 2024 NCAA Convention and effective August 1, 2024. The committee provided feedback to guide the development of updated criteria and procedures, which will be reviewed by the committee at its next meeting.
6. **Future meetings.** Biweekly meetings are tentatively scheduled for appeals or other business and canceled if not necessary. The annual in-person meeting will be held April 11-12, 2024.
7. **Adjournment:** The meeting was adjourned at approximately 11:55 a.m. Eastern time.
