



**REPORT OF THE  
NCAA HIGH SCHOOL REVIEW COMMITTEE  
NOVEMBER 16, 2023, VIDEOCONFERENCE**

**ACTION ITEMS.**

**INFORMATIONAL ITEMS.**

- 1. Feedback on revised transcript review procedures.** The NCAA High School Review Committee received an update from high school review staff regarding revised transcript reviews. They affirmed that internal operating procedures may include staff discretion to not pursue revised transcript documentation in situations where the specific revision is low or no risk (e.g., an approved core course title is changed to another approved core-course title), or where the prospective student-athlete in question is a final qualifier for all NCAA divisions without the use of the specific revision.
- 2. Discussion regarding agricultural science courses.** The committee received an update from high school review staff regarding agricultural science course submissions. The staff explained challenges that arise due to lack of specific criteria for review of such courses. The committee supported the development of agricultural science criteria to increase reliability of review outcomes. The high school review staff will conduct research and draft criteria to be reviewed by the committee at a future meeting.
- 3. Discussion regarding financial literacy courses.** The committee received an update from high school review staff regarding course submissions related to financial literacy. The committee noted that the existing criteria for review of economics courses should be evaluated for relevance in reviewing financial literacy courses. The committee also discussed the role of career prep or personal skills courses in college preparatory programs. They reached a consensus that courses such as financial literacy and personal finance are typically considered non-core courses (e.g., electives) for high school graduation and college admissions purposes.
- 4. Future meetings.** Biweekly meetings are tentatively scheduled for appeals or other business and canceled if not necessary. The annual in-person meeting will be held in Spring 2024 in Indianapolis (date to be determined).
