

REPORT OF THE NCAA PLAYING RULES OVERSIGHT PANEL FEBRUARY 21, 2018, TELECONFERENCE

ACTION ITEMS.

INFORMATIONAL ITEMS.

- **1. Welcome and announcements.** The chair welcomed those on the call and thanked everyone for their time.
- 2. Review of the PROP January 17, 2018, annual meeting report and January 10 email vote report. The panel reviewed and approved the annual meeting report and January 10 email vote report as written.
- 3. NCAA Women's Volleyball Rules Committee annual meeting report and comment period report. The panel approved the seven rules proposals submitted by the Women's Volleyball Rules Committee. These changes included:
 - Combining the two rule categories of "in/out" and "touch" into one reviewable challenge for matches using the Challenge Review System;
 - Adding the 3-meter attack line as a reviewable decision;
 - Allowing each team an additional challenge if the match goes to a fifth set;
 - Reducing the maximum allowable time for intermission between sets two and three to five minutes for all matches and
 - Simplifying the "solid-colored" jersey rule.
- 4. NCAA Men's and Women's Water Polo Rules Subcommittee annual meeting report, February 13 teleconference report and comment period report. The panel approved the three rules proposals submitted by the Men's and Women's Water Polo Rules Subcommittee. These changes included creating an option for officials to issue a yellow/red card to address disruptive behavior by a head coach, adding a rule to penalize the simulation of a foul and clarification of the penalty for a misconduct that occurs during administrative time while the ball is out of the water.
