# June 1, 2023, through May 31, 2024

#### Men's Lacrosse

Nov. 6 (7 a.m.) to Nov. 8 (7 a.m.), 2023, (during the 48 hours prior to 7 a.m. on the initial date for the signing **DEAD PERIOD** of the National Letter of Intent). Nov. 27 to Dec. 23, 2023 **QUIET PERIOD** Dec. 4 to 12, 2023, (two days before the Intercollegiate Men's Lacrosse Coaches Association Convention **DEAD PERIOD** through the two days following the convention). Exception for events held in conjunction with **EVALUATION PERIOD** the convention. May 23 to 28 (noon), 2024, (the Thursday before the NCAA Division II Men's Lacrosse Championship to the **DEAD PERIOD** Tuesday at noon after the championship).

#### Men's and Women's Wrestling

July 24 to 30, 2023, (the Monday before the National Wrestling Coaches Association Convention through the day of adjournment of the convention).

Nov. 6 (7 a.m.) to Nov. 8 (7 a.m.), 2023, (during the 48 hours prior to 7 a.m. on the initial date for the signing of the National Letter of Intent).

# Recruiting periods defined

#### **OUIET PERIOD**

A quiet period is that period of time when it is permissible to make in-person recruiting contacts only on the member institution's campus. No in-person, off-campus recruiting contacts or evaluations may be made during the quiet period.

#### **DEAD PERIOD**

A dead period is that period of time when it is not permissible to make in-person recruiting contacts or evaluations on or off the member institution's campus or to permit official or unofficial visits by prospective student-athletes to the institution's campus.

### **EVALUATION PERIOD**

An evaluation period is that period of time when it is permissible for authorized athletics department staff members to be involved in off-campus activities designed to assess the academic qualifications and playing ability of prospective student-athletes. No in-person, off-campus recruiting contacts shall be made with the prospective student-athlete during an evaluation period.



## **All Other Sports**

Nov. 6 (7 a.m.) to Nov. 8 (7 a.m.), 2023, (during the 48 hours prior to 7 a.m. on the initial date for the signing of the National Letter of Intent).
