2020 Regional Rules Seminar Frequently Asked Questions

Question No. 1: How can I participate/register for live webinars?

Answer: To attend a live webinar, participants must pre-register for each webinar. To register for a webinar:

- 1. Click here, read information on the welcome page and click "Start Registration."
- 2. Once in the registration page, click through each prompt and provide all necessary information and select the sessions/activities that you would like to join.
- 3. You will be asked for your email address. Please use the email address you use to login to NCAA My Apps. If you are unsure of your NCAA My Apps account information, please contact your campus Single-Source Sign-On administrator. If you do not currently have access to NCAA My Apps, please use your official work/school email address to register for 2020 NCAA Regional Rules Seminar sessions. To gain access to NCAA My Apps, contact your campus SSO administrator. If you are unsure who your campus SSO administrator is, check with your compliance officer in Division I or Division II and the director of athletics for Division III.
- 4. Upon completing your registration, you will receive a confirmation email notifying you that you've completed registration, and you will receive individual emails each containing the unique link for each webinar you signed up to attend. For example, if you registered for five live webinar sessions, you will receive five individual emails each containing the unique link for you to attend that specific webinar. Please note you will receive each individual email containing the unique webinar link approximately two to three days prior to the date of the webinar.

Question No. 2: Is there a deadline to register for each live session?

Answer: Yes. Registration for each live webinar session will remain open until three days prior to the date of the live session. Therefore, if a session occurs June 8, registration for that session will close at 11:59 p.m. Eastern time Friday, June 5.

Question No. 3: Are sessions offered only once?

Answer: All webinar sessions will be recorded; however, the following Division III sessions are the only sessions that will be repeated:

Division III Bylaw 13 – noon to 1 p.m. Eastern time June 22;

Division III Bylaw 14 – 4 to 5 p.m., Eastern time June 22;

Division III Bylaw 17 – noon to 1 p.m. Eastern tme June 23; and

Division III New Legislation – 4 to 5 p.m. Eastern time June 23.

Question No. 4: What are the fees to tune into this year's virtual sessions?

Answer: There are no fees to attend live webinar sessions conducted as part of the Regional Rules Seminar; however, pre-registration for each webinar is required.

Question No. 5: What technology needs do participants need to have access to?

Answer: Participants will be sent a unique link for each webinar they registered to attend. On the date/time of scheduled webinars, participants should join the webinar through a device that connects to the internet and allows for audio/visual capabilities (e.g., laptop or desktop computer, tablet). Several webinars will be interactive and allow participants to ask questions in real time through a conversation tab within the webinar browser.

Question No. 6: Do participants need to download something to participate?

Answer: No; however, participants will need to access the unique link for each webinar they preregistered to attend.

Question No. 7: How can I check my existing technology in advance to ensure that I am able to participate in the virtual seminar?

Answer: You can check your existing technology by clicking the "Join" button in your calendar invitation. You will be able to walk through some of the steps required to get prepared for the actual session. Items to note include allowing your web browser access to your microphone and webcam. This may be enabled but if not, you will receive a prompt from your web browser to do so.

Question No. 8: Will there be technical support before and/or during the online seminar in case I need help?

Answer: Please contact your institution's IT support for assistance. This approach should be no different than seeking assistance for any other non-NCAA webinar-related issues. The following link can be used as reference: https://help.webex.com/en-us/.

Question No. 9: Will the sessions be recorded and if so, when/where can I access them?

Answer: Yes. All live sessions will be recorded and made available to NCAA members in the NCAA Learning Portal after the seminar by mid-July. Once webinar recordings are available, you will be able to

• Login to NCAA My Apps and access the NCAA Learning Portal tile; and

• Within the Learning Portal, access "My Courses." A list of sessions you attended will appear. Each session will contain available resources.

In addition to live webinar sessions, supplemental educational resources and downloadable presentations on Division I and Division III rules will be posted in June and July.
