Division I Football Hot Topics – Intermediate

Augustus I/II

This session will focus on the hot topic issues impacting football. Staff will provide an update on topics the Division I Football Oversight Committee is reviewing and a high-level update on new legislation, education columns and interpretations.

Participants will be broken into small groups, provided scenarios and asked to collaborate with their peers to determine student-athlete eligibility impact, institutional impact and whether other conditions or guidance documents may apply (e.g., repayment of a benefit, application of student-athlete reinstatement previously approved request list). Is your campus prepared for the NCAA Post-Eligibility Insurance Program that begins August 1? The program will be available to all student-athletes at all member schools in all divisions. For up to two years (104 weeks) after student-athletes separate from school or voluntarily withdraw from athletics, the program will cover accident medical expenses for athletically related injuries sustained during participation in a qualifying intercollegiate sport. Coverage will be provided on an excess basis for properly documented injuries that occur on or after August 1. (Attendees should note that post-eligibility insurance does not replace the requirement for NCAA Division I member institutions, and Division II and III programs that sponsor a Division I sport, to provide medical care to student-athletes for athletically related injuries for two years after graduation or separation from the institution.) For student-athletes to benefit from NCAA post-eligibility insurance, member schools in all divisions will be responsible for retaining injury documentation until the benefit

period of two years (104 weeks) is exhausted, plus an additional year. Join this session for an introduction to the NCAA Post-Eligibility Insurance Program and a preview of the claims process.
