SESSION KEY

Introductory: These sessions will provide attendees with basic, introductory information about the topic(s) listed in the session description. Presenters will primarily use introductory language, concepts and examples in these sessions.

Mid-level: These sessions will provide attendees with information that is above a basic level of understanding on the topic(s) listed in the session description. Presenters will apply more advanced language in these sessions compared to introductory-level sessions but will not display an abundance of complex language, examples or concepts.

Advanced: These sessions will provide attendees with information that is more advanced in nature. Presenters will use advanced and complex language, concepts, and examples throughout these sessions.

9:45 to 10:45 a.m.

Division I Financial Aid Hot Topics – Advanced Grand 6

This advanced-level session will provide attendees with the opportunity to engage in collaborative discussions with financial aid professionals and compliance administrators with financial aid responsibilities. Attendees are encouraged to discuss financial aid hot topics amongst peers and develop collaborative solutions to issues related to financial aid. This session is intended to allow attendees to engage in a robust table discussion about the issues facing the membership and attendees are encouraged to be prepared to actively participate in this session.

Division I Compliance 101: Introduction to Playing and Practice Seasons – Introductory Grand 7-8

This foundational-level session will provide new compliance administrators an overview of playing and practice seasons legislation and frequently asked questions received by the academic and membership affairs staff. Division I Basics of Delayed Enrollment and Amateurism Certification Process – Introductory Grand 7-8

This session will provide an introduction to Division I delayed enrollment legislation and the amateurism certification review process.

Division I Conference and Campus SAAC Advisors Discussion – Mid-level Grand 9-10
Discuss the priorities of Division I National SAAC, conference and campus SAAC best practices and communication efforts between the national office and the membership.

Division I Football Hot Topics (*repeated*) – Advanced Grand 6
This session will focus on the hot topic issues impacting football. Staff will provide an update on topics the NCAA Division I Football Bowl and Championship Oversight Committees are reviewing and a high-level update on new legislation, education columns and interpretations.

This programming is designed for new academic and compliance professionals. Attendees will learn to identify fundamental legislation, effectively explain the legislation to institutional constituents, apply specific academic legislation to factual scenarios and analyze potential academic issues and processes.

Division I Core Guarantees – Mid-level Grand 9-10
Join NCAA staff from across the national office during this panel discussion to hear information on the new core guarantees for Division I student-athletes. Panelists will explain the latest



information regarding policies and procedures, best practices and other relevant guidance related to implementing new rules that benefit student-athletes participating in Division I athletics.

Division I Student-Athlete Reinstatement Hot Topics – Mid-level Grand 5

This session will focus on hot topics impacting the Division I student-athlete reinstatement process. Attendees can expect information specific to recent changes made to the policies and procedures that govern the submission of reinstatement requests and hardship, season of competition and extension of eligibility waivers.

Division I Update on All Things Women's Basketball – Mid-level Grand 7-8

This session will cover non-rules/compliance topics related to Division I women's basketball. Topics such as the women's basketball strategic plan, NET, playing rules and tournament selections will be reviewed with attendees.

This recruiting session will provide factual scenarios related to tryouts and camps and clinics legislation. Session attendees should have a foundational understanding of the tryouts and camps and clinics legislation. Additionally, this session will provide attendees with a tangible resource (e.g., one pager) that may be used for rules education.

Division I Interpretations 101 – Introductory Grand 1

This introductory-level session will provide attendees with key information and tips to consider when researching and drafting interpretations submitted to academic and membership affairs.



This session will also provide attendees with key information and tips to consider when institutions work with NCAA staff to submit appeal requests related to interpretations to academic and membership affairs.

Division I Advanced Progress-Toward-Degree/Certification Demonstration (*repeated*) – Advanced

This session will provide an advanced review of Division I progress-toward-degree legislation and interpretations with a focus on certifying academic eligibility.
