SESSION KEY

<u>Introductory</u>: These sessions will provide attendees with basic, introductory information about the topic(s) listed in the session description. Presenters will primarily use introductory language, concepts and examples in these sessions.

<u>Mid-level</u>: These sessions will provide attendees with information that is above a basic level of understanding on the topic(s) listed in the session description. Presenters will apply more advanced language in these sessions compared to introductory-level sessions but will not display an abundance of complex language, examples or concepts.

<u>Advanced</u>: These sessions will provide attendees with information that is more advanced in nature. Presenters will use advanced and complex language, concepts, and examples throughout these sessions.

THURSDAY, MAY 29

8:30 to 9 a.m.

Division II Welcome and Activity – Introductory

Staff will welcome participants with introductions and a short ice breaker activity.

9 to 10 a.m.

Division II Governance Updates – Introductory

During this session, participants will receive an update on the recent work of the committees within the Division II governance structure. Further, participants will receive an overview of the Division II Think Tank outcomes.

10:15 to 11:15 a.m.

Division II Eligibility: Two-Year College Transfers – Introductory

During this session, participants will receive a broad overview of two-year college transfer requirements. Additionally, participants will be able to practically apply newly adopted legislation through interactive case studies.

11:30 a.m. to noon

Teamworks Panel Discussion: Leveraging Digital Solutions for Compliance Efficiency

During this session, participants will be guided through the various components of Bylaw 15, including but not limited to reductions and cancellations of athletics aid. This interactive session will include case studies to assist participants in properly applying various financial aid concepts.

4:45 to 5:30 p.m.

Division II Student-Athlete Reinstatement Hot Topics – Mid-level

This session will focus on hot topics impacting the Division II student-athlete reinstatement process. Attendees can expect information specific to recent changes made to the policies and procedures that govern the submission of reinstatement requests and hardship, season of competition and extension of eligibility waivers.

FRIDAY, MAY 30

9 to 10 a.m.

Division II Progress-Toward-Degree Requirements: Back to Basics – Introductory

During this session, participants will receive an overview of the progress-toward-degree legislation. Participants will also test their understanding of the legislation through interactive activities, while also having the opportunity to discuss certification best practices that are done on their campus. Finally, participants will receive an overview of the waiver directives and previously approved waiver checklist.

10:15 to 11:15 a.m.

Division II Athletics Eligibility: What Can I Do? – Introductory

During this session, participants will review examples of activities and benefits that may jeopardize a student-athlete's athletics eligibility. Participants will have the opportunity to work through various interactive case studies to assist in properly applying the legislation.

Division II Transfer Portal – Mid-level

In this session, attendees will view NCAA Transfer Portal data trends and receive valuable tips on navigating the functions of the transfer portal. Attendees will also preview enhancements and provide feedback for version 8.0.
