Intent: To specify that an active member institution shall complete an equity, diversity and inclusion review at least once every five years and provide written confirmation of completion to the national office. **Effective Date:** August 1, 2019

Intent: In sports other than men's ice hockey and skiing, to specify that, prior to collegiate enrollment, a professional sports team/organization may provide payment for educational expenses and services (e.g., tuition, fees, room and board, books, tutoring, standardized test preparatory classes) provided to a prospective student-athlete, provided such payment is disbursed directly to the individual, organization or educational institution (e.g., high school, preparatory school) providing the educational expenses or services. **Effective Date:** Immediate

Title: RECRUITING -- RECRUITING CALENDARS -- FOOTBALL -- EXTEND FEBRUARY AND JULY DEAD PERIODS

Intent: In football, to extend the dead period surrounding the initial signing day of the regular National Letter of Intent signing period through the last day of February; and, in bowl subdivision football, to extend the July dead period through the end of the month.

Intent: To specify that only athletically related institutional financial aid and educational expenses awarded by the U.S. Olympic Committee or a U.S. national governing body (or, for international student-athletes, the equivalent organization of a foreign country) shall count toward maximum institutional grant-in-aid limitations. **Effective Date:** August 1, 2019

Intent: To specify that a transfer student from a four-year institution who has received a waiver of or qualifies for an exception to the transfer residence requirement shall not be eligible to participate in competition in which his or her performance could be used for NCAA championship qualification or consideration if he or she participated in competition at the previous four-year institution in the same sport in which his or her performance could have been used for NCAA championship qualification or consideration.
