

**CONCEPTS UNDER CONSIDERATION FOR AUTONOMY LEGISLATION
2019-20 LEGISLATIVE CYCLE**

This chart sets forth the concepts under consideration for potential legislative proposals to be addressed by the autonomy conferences in the 2019-20 legislative cycle.

Area of Autonomy	Concept	Submitting Conference(s)
Athletics Personnel	In women's rowing and swimming and diving, to specify that a graduate assistant coach may receive four complimentary tickets to all the institution's intercollegiate athletics events.	Big 12 Conference.
	To eliminate the requirement that a student assistant coach must be a student-athlete who has exhausted his or her eligibility in the sport or has become injured to the point that he or she is unable to practice or compete ever again.	Big 12 Conference.
Athletics Personnel and Awards, Benefits and Expenses	To specify that legislation applicable to the Olympic Games and Olympic teams and athletes shall apply to the Paralympic Games and Paralympic teams and athletes; further, to specify that legislation applicable to the Pan American Games shall apply to the Parapan American Games.	Atlantic Coast Conference, Big 12 Conference, Big Ten Conference, Pac-12 Conference, Southeastern Conference.
Awards, Benefits and Expenses	To permit an institution to negotiate payment plans, group rates and/or reserve a block of rooms with an off-campus housing complex on behalf of student-athletes and prospective student-athletes who have committed to the institution.	Big 12 Conference.
	To specify that a student-athlete who has been designated by the U.S. Olympic and Paralympic Committee and the sport-affiliated national governing body (or the international equivalent) as an elite athlete may receive development training expenses from the USOPC or the NGB (or the international equivalent) related to sport experts other than coaches, training partners and travel for parents or guardians, coaches and sport experts. Time Demands	To permit a team whose season ends within one week of or during the institution's final-examination period to conduct an end-of-season team banquet during the seven-day discretionary period; further, to specify that team entertainment may not be included in the event. 	To specify that a student-athlete who has been designated by the U.S. Olympic and Paralympic Committee and the sport-affiliated national governing body (or the international equivalent) as an elite athlete may participate in an individual workout session conducted by a coaching staff member without such activity being subject to daily or weekly limits on required athletically related activities, provided the student-athlete initiates the request to participate in the workout session and does not miss class.
