## **Sport Oversight Committees Legislative Process**

Have the authority to adopt legislation related to their sport in the following areas: 1) Conduct of athletics personnel (NCAA Bylaw 11); 2) Recruiting (NCAA Bylaw 13); 3) Playing and practice seasons (NCAA Bylaw 17); 4) Processes and procedures related to the administration of the regular season and championship (NCAA Bylaw 31) and 5) Sportsmanship and other ethical behaviors.

#### Start

Sport oversight committees have the authority to adopt legislation in five areas.

They may introduce legislation in other areas, which will be considered by the Administrative Committee through the process for other areas.

## Introduction Deadline

July 9, Oct. 16 and March 25

Proposals must be introduced at least 90 days before an Administrative Committee meeting.

# Publication Date

July 30, Oct. 23, April 1

Proposals will be published within seven days of the introduction deadline.

## Membership Feedback

July 30-Aug. 16, Oct. 17-Nov. 29, March 26-May 2

Proposals will be available for membership review and feedback.

# Sport Oversight Committee Action

#### Aug. 24-29, Dec. 1-8 or May 4-11

Sport oversight committee meets to review feedback and/or suggested amendments provided by the membership during the initial comment and feedback period.

The sport oversight committee may adopt, defeat, table, withdraw or amend a proposal.

Each action requires a simple majority, with the exception of a two-thirds majority to amend a proposal.

#### **Notice**

## Sept. 2, Dec. 11 or May 14

Action on proposals scheduled for review are published.

### Additional Comment Period

Sept. 2-Oct. 6, Dec. 11-Jan. 13, May 14-June 22

Additional comment period occurs.

#### Final

#### Oct. 7-8, Jan. 14 or June 23-24

Administrative Committee can allow a proposal adopted by a sport oversight committee to remain as adopted, to remain as adopted, or it may choose to table, remand or defeat the proposal.

If the Administrative Committee takes no action, the proposal is final as adopted by the sport oversight committee.

The Board of Directors may review and take action related to legislation adopted or defeated by a sport oversight committee or Administrative Committee.


