Division III Philosophy Statement Survey Summary of Findings

Introduction

The Division III Strategic Planning and Finance Committee distributed a survey to seek membership input on potential changes to the Division III Philosophy Statement (Bylaw 20.11). The questions were designed to solicit views on a draft statement that may be used to shape a possible legislative proposal to amend the Philosophy Statement.

The web-based survey was voluntary, and all responses are confidential. Findings are reported in the aggregate, appropriately grouped with other respondents (e.g., by position title). Item responses were indicated on a six-point scale of strongly agree to strongly disagree.
