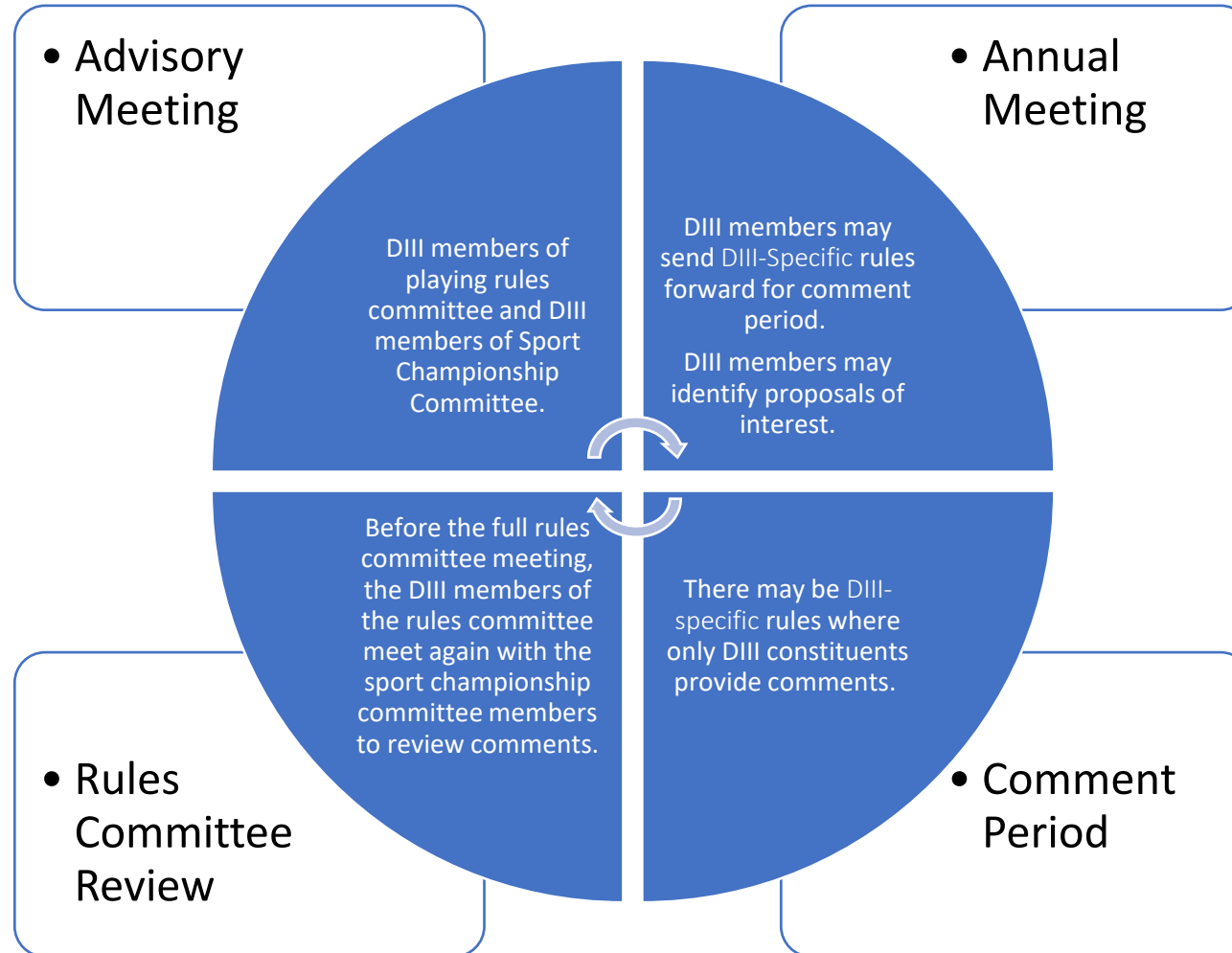

# Division III Federated Process

## PROP Review of Proposals

DIII members will vote on DIII-Specific issues, applying the same standard of review that the entire panel does for common rules.

# ***Framework for integral rules***

- Rules with a health and safety impact.
- Field dimensions, court markings, permissible logos on field/court.
- Scoring and timing rules, including rules surrounding overtime.
- Conduct/sportsmanship rules.
- Rules addressing penalty enforcement.
- Uniform rules.
- Equipment rules (ball/stick specifications, player equipment).
- Technical rules (individual sports).
