# Order of Legislative Business

- Initial motion to accept notice.
- Confirm or change order of proposals.
- Ratify blue page proposals through acceptance of Official Notice. By motion of a delegate, individual proposals within appendices (blue pages) may be removed for separate consideration.

### NCAA Proposal No. 2019-2

PLAYING AND PRACTICE SEASONS – FOOTBALL – ESTABLISHING PRESEASON START DATE 23 DAYS BEFORE THE INSTITUTION'S FIRST CONTEST.

- Effective Date: August 1, 2019.
- <u>Source</u>: NCAA Division III Presidents Council [Management Council (Playing and Practice Seasons Subcommittee)].

#### **Current Rule**

- Start of preseason is determined by a formula based on institution's first day of classes and first contest.
- The formula contemplates the opportunity for traditional two-a-day practices when classes are not in session.
  [Traditional two-a-day practices were recently eliminated.]
- A day off of physical athletically related activity is not mandated prior to the start of classes.





- Start of preseason would be 23 days before the first actual contest.
- Prohibits physical athletically related activity one day per each week of the preseason after the acclimatization period.

# NCAA Proposal No. 2019-2-1

PLAYING AND PRACTICE SEASONS – FOOTBALL – ESTABLISHING PRESEASON START DATE 23 DAYS BEFOR THE FIRST CONTEST – EXCEPTION THURSDAY CONTEST.

- Effective Date: August 1, 2019.
- <u>Source</u>: NCAA Division III Presidents Council (Management Council).

- Amends Proposal No. 2019-2 to mirror current legislation for Thursday contests during the opening weekend.
- For an institution that conducts its first contest on Thursday of the opening weekend, the start of preseason would be 23 days before the Friday following the first contest.

#### Process

- Proposal 2019-2 will be moved and seconded.
- Next Proposal 2019-2-1 will be moved and seconded.
- Discussion will occur on 2019-2-1.
- There will be two votes.
- The first vote is to determine if Proposal 2019-2 should be amended by 2019-2-1.
- If yes, then the second vote is on Proposal 2019-2 as amended.
- If 2019-2-1 is not approved, then the second vote is on Proposal 2019-2 as originally proposed.

# NCAA Proposal No. 2019-4

MEMBERSHIP – CONDITIONS AND OBLIGATIONS – STUDENT-ATHLETE GRADUATION RATE REPORTING.

- <u>Effective Date</u>: August 1, 2019. [First reporting date is June 1, 2020].
- <u>Source</u>: NCAA Division III Presidents Council [Management Council (Diversity and Inclusion Working Group)].

#### **Current Rule**

- Annual submission of student-body enrollment and graduation rate data is required.
- Annual submission of student-athlete graduation rate data is voluntary.



- Requires institutions to annually submit studentathlete graduation rate data in addition to submitting student-body enrollment and graduation rate data.
- Failure to submit the data render an institution's teams and individuals ineligible to participate in NCAA championships for that year.





#### NCAA Proposal No. 2019-5

AMATEURISM – PRE-ENROLLMENT EDUCATIONAL EXPENSES.

- Effective Date: August 1, 2019.
- <u>Source</u>: NCAA Division III Management Council (Interpretations and Legislation Committee).



#### **Current Rule**

 A prospective student-athlete (PSA) may not receive expenses for secondary school education based on athletics ability from an outside organization or an individual.





- Permits outside organizations or individuals to provide grants, scholarships, etc. based on athletics to pay for secondary school educational expenses.
- The awards must be disbursed through the secondary institution.





### NCAA Proposal No. 2019-7

RECRUITING – SOCIAL MEDIA AND PUBLICITY – EXCEPTIONS – CONNECT WITH PROSPECTIVE STUDENT-ATHLETES.

- Effective Date: Immediate.
- <u>Source</u>: NCAA Division III Management Council (Interpretations and Legislation Committee).

#### **Current Rule**

 Coaches may not communicate publicly (including friend or follow) with a PSA via social media until May 1 of the PSA's senior year in high school and then only if the PSA has submitted a financial deposit.



2019 CONVENTION ORLANDO



- Athletics department staff members would be permitted at any time to:
  - Connect with PSAs on social media platforms (e.g., friend, follow).
  - Take actions on social media platforms that indicate approval (e.g., like, favorite, republish) of content generated by the PSA or in which PSAs are publicly linked.
- Substantive comments with a PSA on social media remain subject to the current legislation.

### NCAA Proposal No. 2019-3

PLAYING AND PRACTICE SEASONS – FIELD HOCKEY AND SOCCER PRESEASON – ESTABLISHING A THREE-DAY ACCLIMATIZATION PERIOD.

- Effective Date: August 1, 2019.
- <u>Source</u>: City University of New York Athletic Conference and New Jersey Athletic Conference.



#### **Current Rule**

- No restrictions on amount of practice time during the preseason for field hockey and soccer.
- The length of preseason is determined by counting back 16 units from the first scheduled competition.





- Allows institutions to start preseason practice three days earlier than what is currently allowed.
- Requires an acclimatization period during the first three days of preseason practice. During this period, a team would be limited to one practice session (no longer than three hours) and a one hour walk-through session with a minimum of three hours rest between the activities.
- After the acclimatization period, institutions would be limited to two on-field practices (no more than six hours) with at least three hours of rest between the two sessions.

### NCAA Proposal No. 2019-6

ELIGIBILITY – FINAL TERM BEFORE EXPERIENTIAL LEARNING.

- Effective Date: August 1, 2019.
- <u>Source</u>: NCAA Division III Management Council (Interpretations and Legislation Committee).

#### **Current Rule**

- Permits a student-athlete to participate while enrolled less than full time in the final semester/quarter of their academic program.
- The student-athlete must be carrying for credit all courses needed to complete the degree.
- If the student-athlete has an outstanding experiential learning requirement that is not taken in this term, the student-athlete does not qualify for the existing exception and must be enrolled full time to participate.



 Permits a student-athlete to participate while enrolled less than full time provided they are carrying for credit the courses necessary to complete the degree, except for an outstanding experiential learning requirement.
