



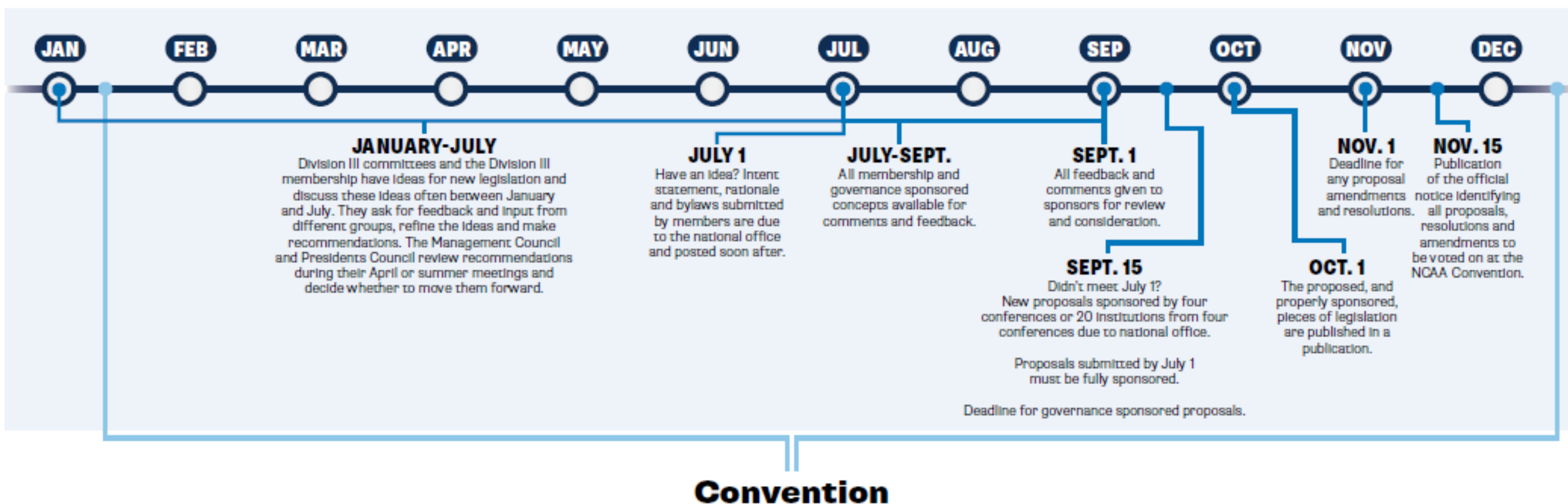

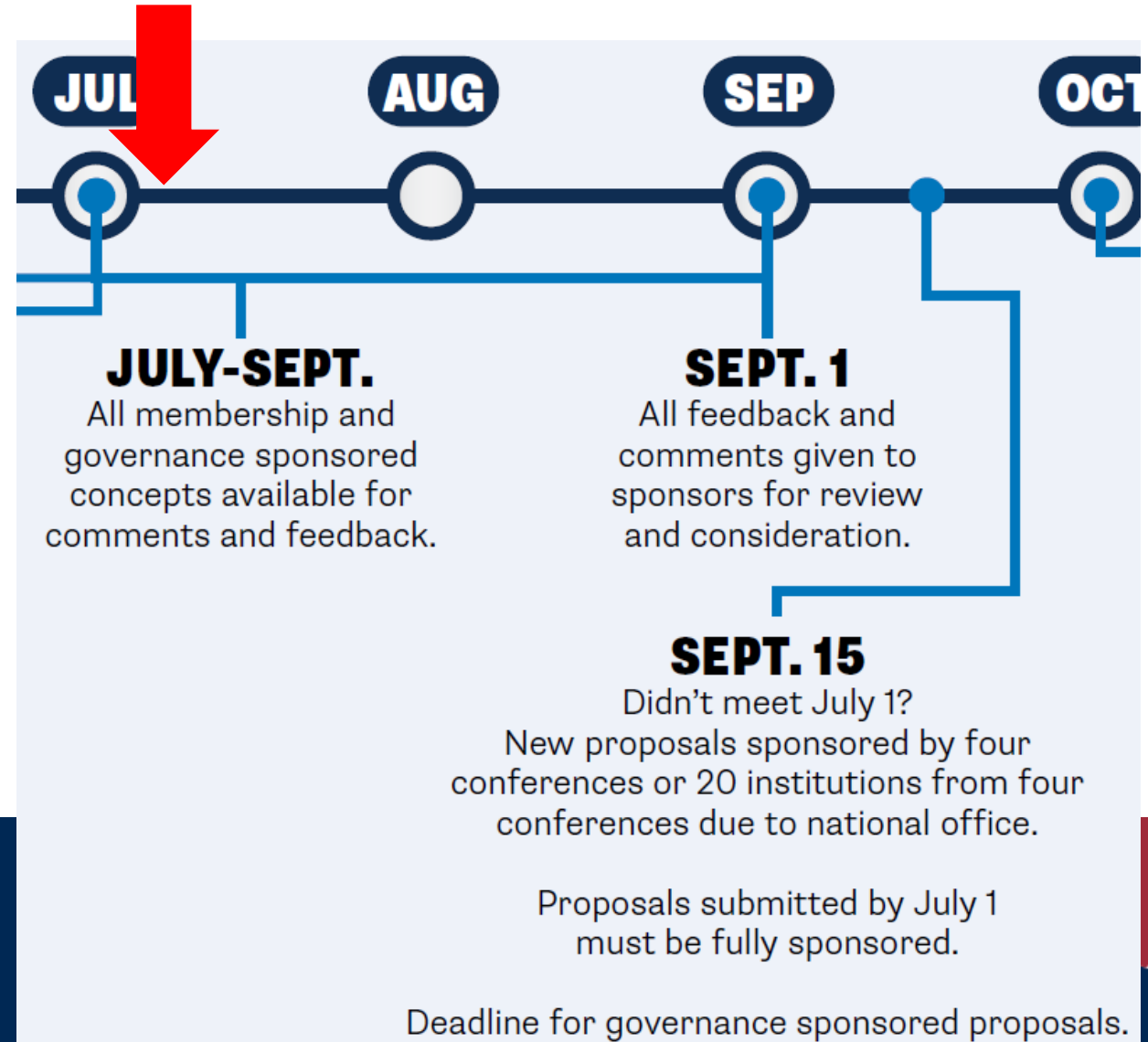
Legislative Calendar.
