Conference membership is available to duly elected athletics conferences of colleges and universities that conduct conference competition and determines a champion in one or more sports in which the NCAA conducts championships. All the members of the conference shall be active members of the NCAA.

An athletics conference desiring to become a Division I single-sport conference in a sport, other than basketball and football, that has a Division I championship shall be composed of at least six active NCAA members, at least 75% of which must be active Division I programs.

This form (and the application fee) must be received by the national office by **June 1** for a membership effective August 1 of the following academic year. A check in the appropriate amount for annual dues shall accompany the application. Please find information on the submission of the application fee on a separate form enclosed with this application. Should the applicant fail election, the dues paid shall be refunded.
