

June Scholastic Events for High School Participants

June scholastic events allow high school boys basketball players the opportunity to develop their skills and showcase their talent in front of college coaches through a series of events hosted by state high school coaches associations and high school athletics organizations across the country.

Event participants are considered “recruits” for purposes of NCAA rules and regulations. All recruits must meet specific requirements to be eligible to participate in college sports, and NCAA schools commit to responsible recruiting standards to help recruits make informed decisions. Incorporating education at June scholastic events will provide recruits with important information on NCAA Division I rules while contributing to a culture focused on minimizing the role of harmful outside influences or excessive contact or pressure on high school recruits interested in playing college basketball.

WHO CAN PARTICIPATE

Recruits: Those invited by host associations must be currently enrolled in high school and meet the requirements set by either the NFHS or the NCAA.

Coaches: NCAA legislation permits NCAA Division I, II and III men's basketball coaches to attend.

Host associations will determine specific admission requirements for coaches and the general public.

EVENT FORMAT

The National High School Basketball Coaches Association suggests that one (or a combination) of the five event models below be used for June events.

Showcase (individuals – instruction, drills for skills, grouped for games).

Team Camp (scholastic teams – invited for instruction, drills for skills and games).

Jamboree (“select” teams – formed by league or area within a state to learn, drills for skills and games).

Metro Area (individuals or teams in a metro area).

Multistate (players and/or teams from several states for Showcase and/or Jamboree format).

CONTACT RULES FOR DIVISION I COACHES

When a recruit is participating in June scholastic events:

Allowed

A Division I coach **may call, email or text** with the recruit, recruit's family and high school beginning June 15 after the recruit's sophomore year.

Not allowed

A Division I coach **may not have in-person contact** with:

- » The recruit;
- » The recruit's family;
- » The recruit's coach; or
- » An individual associated with a recruit.

Note: The above list of individuals should not approach Division I coaches at the event.

EDUCATIONAL RESOURCES

The NCAA will develop and deliver educational resources on topics related to NCAA Division I rules that recruits must follow and make those resources available to event operators (or designees) prior to the June scholastic events.

PLANNING

To appropriately execute the delivery of educational resources to recruits participating in June scholastic events, each event operator (or designee) is asked to identify an individual and provide their email address for the NCAA to send educational resources.
